# Minutes of the KPFK Local Station Board Meeting of January 25, 2015

A rescheduled regular monthly meeting of the KPFK Local Station Board was held on Sunday, January 25, 2015, 1:21 PM, at the Aris and Carolyn Anagnos Peace Center, 3916 Sepulveda Blvd., Culver City, CA 90230, the Chair (Tej Grewall) being in the chair and the Secretary (John P.
