- **II. Report Out from Earlier Executive Session of February 8, 2011.** PNB Chair Pro Tem Summer Reese gave the following Report Outs:
 - **a. Director Resignation.** The PNB reaffirmed the decision of the Pacifica Foundation Board of January 21, 2011 by which Mr. Dan Siegel was deemed to have resigned the position of Pacifica Foundation Delegate prior to the January 13, 2011 KPFA PNB Director Election.
 - **b.** Arqueta Matter. PNB authorized Counsel to offer mediation in the Arqueta matter, and if that was rejected, for Counsel to proceed in preparing for the hearing scheduled in that matter for February 18, 2011.
- III. Filling a PNB Affiliate Director Position. Affiliate Director, Joseph Orozco had resigned as PNB Director. Discussion followed about how to fill the position. As per the Pacifica Bylaws, the position was to be filled by an election from those remaining from the last previous election. For this election, electronic email ballots were to be sent to the Pacifica National Office and counted by staff.

HNO Bill Crosier was to act as election coordinator to make sure earlier Q&A of candidates was sent out and that the ballots got out correctly to all PNB members, except Affiliate reps., and gotten back.

<u>Allen moved</u> that ballots for the Affiliate Director position (candidates Jim Bennett and Heather Gray) be sent to the PNB members, with request that ballots be returned to the National Office by Monday, February 21, 2011 by 5:00 pm (PST). HNO motion Approved.

IV. Adjournment. <u>Aaron moved</u> to adjourn. HNO meeting adjourned at 9:30 pm. (ET).
