Further, the Board appointed its Chair Pro Tem, Lawrence Reyes, to be the interim Executive Director temporarily and has scheduled a continuation of its executive session of Thursday, Nov. 14, 2019 for Sunday, Nov. 17 at 8 pm eastern time.

On Nov. 17, 2019 in the continuation of the Nov. 14<sup>th</sup> meeting the Board discussed legal and personnel matters.

That the Board is directed to obtain proposals from mediation and facilitation firms by Wed, Nov. 27, 2019, and make a selection from among these, and negotiate a contract with the selected firm on Dec.5, 2019, and that a task force of this Board shall be commissioned and authorized to work with the selected firm to create a list of areas and topics for discussion and to initiate a structure for the facilitation/mediation.

#### This amendment is accepted without objection.

# ALTERNATE/SUGGESTED MOTION On Mediation – Nancy Sorden and Eileen Rosin with input from Arthur Schwartz

Whereas, WBAI has been restored, with local programming, to the airwaves; and

Whereas, Given the position of the Pacifica National Board, continued litigation would be both incongruous and counterproductive; and

Whereas, Counsel for Petitioners in the NYC litigation has proposed a broad settlement stipulation which encompasses a commitment by all to fiscal responsibility and broadcasting in accordance with the law; and

Whereas, There is a strong sense of this Board that a mediation/facilitation process is the best route forward to address the financial and structural problems facing Pacifica; and

Whereas, There exist firms specializing in mediation and facilitation from which Pacifica can seek reasonable and affordable proposals to facilitate a problem-solving discussion among the Board and the Pacifica stations to address the financial and structural issues facing Pacifica; therefore

*Resolved,* That Foster Garvey, the counsel representing Pacifica in the NYC litigation, is directed to execute the settlement agreement and dismissal in the form annexed hereto; and

It is *further Resolved*, That the Board is directed to obtain proposals from mediation and facilitation firms, and make a selection from among these, and negotiate a contract with the selected firm, and that a committee of this Board shall be commissioned and authorized to work with the selected firm to create a list of areas and topics for discussion and to initiate a structure for the facilitation/mediation. That the Board is directed to obtain proposals from mediation and facilitation firms by Wed, Nov. 27, 2019, and make a selection from among these, and negotiate a contract with the selected firm on Dec.5, 2019, and that a task force of this Board shall be commissioned and authorized to work with the selected firm to create a list of areas and topics for discussion and to initiate a structure for the facilitation/mediation.
