Program Director's Report:

BAI Staff and BAI LSB:

Our programmers are tasked with raising funds on air. Last month R. Paul answered questions about the LSB at our Staff Meeting. I would like to see a regular monthly report to Staff from LSB members.

Attached are some areas which can be addressed.

BAI Website:

The WBAI website is outdated and is in dire need of an update. It is not intuitive. It's time consuming, breaks often. What's really needed is a total reboot, a new interactive website with a grant to make this happen. I understand some LSB members are or could be working on this. What is the status? We are also in need of a grant and funding for a social media person to help build the audience.

4 Times Square: The broadcast tower which houses our transmitter was shut down in October for quite a few days, interrupting our broadcast day and listenership. The shutdowns were erratic.. they were on, they were off, they ended early, they went late. This all caused disruptions. We are trying to get a rent rebate from them. Meanwhile Berthold is restarting the Tower Fund Campaign to help pay back rent. It was somewhat successful in June 2022. A backup antenna in another location which other public radio stations have is needed. How can WBAI secure funding for this?

PSA's

NYC Dept. of Transportation: Berthold and I secured a reboot of the Vision Zero Things Happen Fast campaign through mid-September. I produced the spots for them.

NYC Dept of Health: We secured a contract to broadcast a PSA for their Bullseye Campaign this month.

Our understanding is that there could be more going forward.

The two campaigns bring in \$10,000 a month. Had we not raised listenership, this wouldn't have been possible.

Midterms: We are producing a five hour special on the midterms on November 8th from 5pm to 10pm hosted by The Indypendent. Many of our hosts are participating in the Special. WPFW is taking our coverage as is one of our affiliates in Tampa. WBAI continues Midterm Election coverage with Democracy Now from 10pm to Midnight.

On Thursday November 10th. we will broadcast a Town Hall from Howard University convened by Dr. Ron Daniels on the impact of the Midterms on Black America and the Pan African World. See splash on our website.
