**Whereas** the level of conflict and seemingly intractable differences among members of the 2019 Pacifica National Board (PNB) have led to paralysis in conducting the Foundation's business, and

**Whereas** the urgency of the issues to be taken up by the PNB demands immediate and focused attention from that same body,

**We move** to seek facilitation/mediation/reconciliation (or any other effective methodology) of the current disputes to resolve these differences sufficiently to allow all PNB directors to work together for the survival and flourishing of the Pacifica Foundation as a whole and of its parts.

We further move that the type of mediation and other particulars\* be proposed by any and all members of the PNB, and that the PNB call a special meeting to discuss and select from among the proposals.

This motion does not in any way impede or curtail the ability of the PNB to meet or function, nor does it postpone or nullify PNB meetings, actions or decisions.

## The following item was not taken up:

8. Motion to create a Commission of Inquiry – Passed by the WBAI LSB on Nov. 13, 2019

Whereas the illegal and unauthorized shut down of WBAI has caused inordinate damage both to WBAI and to the entire Pacifica network; and Whereas proposals are being brought forward for mediation to the Pacifica National Board; and

Whereas any genuine mediation, and all other circumstances, require a truthful account of exactly what transpired to bring about the events at WBAI and Pacifica that occurred on and around October 7, 2019 and such information is important to obtain under any circumstances; Be it hereby Resolved that WBAI LSB urges the Pacifica National Board to immediately create a Commission of Inquiry.

The Commission of Inquiry would be tasked with investigating how the unauthorized shut down of WBAI was planned, who the actors were, and how the action was prepared.

The Commission of Inquiry, will request that all actors in the process provide testimony and all documents deemed by the Commission to be relevant to the inquiry be made available to the commission.

The hearings of the Commission shall be held in public and webstreamed live to the entire Pacifica community.

# The rationale for the KPFT motion – Dewayne Lark

As you can see for the approved minutes posted at KPFTx.org, KC Sinclair was not present or excused on the KPFT LSB meetings of March 20, March 27 and April 10, 2019. It means that at 10:07 PM (when the April 10, 2019 LSB meeting finished), KC Sinclair seat was vacant (\*Article Four, Delegates, Section 9: Removal of Delegates).

According to the Pacifica Foundation Bylaws (\*\**Article Four, Delegates, Section 10: Filling of Vacancies*), the first runner up from the previous election will fill that vacancy which went to reelection in 2019. In the attached picture of the runners up of the election, the first runner up was Michelle Milligan, subsequently she must fill the KC Sinclair vacant seat. At the KPFT LSB meeting of May 15, 2019 the chair announced that Delegate elected Danae Moreno resigned, which means that the next runner up (Susie Moreno), must fill that vacant seat which goes to reelection in 2021.

The motion tonight to be approved by the PNB should correct the names of the Delegates replaced as follows:

"Correct KPFT LSB records to reflect that Delegate Michelle Milligan, first runner up of the previous election, replaced Delegate KC Sinclair which seat was vacated by three consecutive unexcused absences at the end of the KPFT LSB meeting of April 10, 2019.

And that Delegate Susie Moreno, next runner up, replaced Delegate Danae Moreno who's resignation was announced on the KPFT LSB meeting of May 15, 2019."

## (\*) Article Four, Delegates, Section 9: Removal of Delegates:

"....(C) failure of a Delegate to attend three consecutive Local Station Board meetings, which absence have not been excused by a majority vote of the LSB members present at the meetings in question;..."

## (\*\*) Article Four, Delegates, Section 10: Filling of Vacancies:

"If a Delegate position becomes vacant mid-term, that Delegate shall be replaced for the remainder of his/her term by the highest ranked candidate from the last election of Delegate for that Class of Members for that station who was not elected and who is available and continues to meet the Delegate eligibility requirements as set forth in Section 2 (A) or 2 (B) of this Article of these Bylaws....."
