Revenue:

- \$ 25,000 from Subcarrier Rent Radio Maria, with \$10K promised in Jan, 26. Got appropriated by the Pacifica Foundation, and they promised to pay 1½ months 4Times Square Tower Rent, which they did, but then applied this sum to WBAI's outstanding balance receivable. In the opinion of WBAI's management team, the subcarriers get their signal off of our 4 Times Square signal, which diminishes it slightly, plus they utilize the expertise of our long-time field engineer Jake Glanz plus John Ameleh to provide technical assistance. Hence, this money should be applied to our 4Times Square rent.
- ❖ Early spring conventional pledge drive earned \$17K over goal of \$125K through 604 donations. We will be doing a pledge drive starting on Dec. 2 through the end of the year. Over the next year, we will hold a one-week pledge drive every quarter with the expectation of making at least \$100,000 each time.

- ❖ Union pledges \$56,340, with 108 new donors, 131 returning donors, and 73 new BAI Buddies. Over the last 18 months, we have successfully engaged unions representing 3 million households in a sustaining sponsorship program that netted the station \$319,090 in amounts that range from \$500 to \$50,000. These have proven to be a recurring source of revenue with unions renewing their commitments in six months increments. We recently got a \$14,000 pledge from the UFT and a \$50,000 sustaining underwriting from the TWU.
- Thanks to two bequests and one individual donor we have paid close to a half-million dollars in back tower rent and are now only three months behind.
- Over the last 18 months we have also used seasonal appeals that are online and on the air.
- ❖ BAI Buddy Program
 - Increased from \$23,000 to \$25,000 a month.
 - Total buddies increased from 1,264 to around 1,300
 - Average donation per person has increased from \$16.88 to \$17.72
 - Our biggest Buddy is donating \$500 monthly image.png
- ❖ We have also developed \$28,442.41 in PSA sustaining sponsorship from major community institutions: Health + Hospitals, New York City's municipal hospital system, as well as cultural institutions like the Public Theater and the Manhattan Theater Club.
- Major gifts of over \$500 or more from June 1, 2024 through Nov. 6, 2025 total an impressive \$647.930.96, *excluding bequests.*

Payables:

- Payroll \$16,474 (twice a month)
- November's rent of \$2,500 has also paid to Working World (Landlord)
- 4 Times Square Tower pd \$25,5000 by Pacifica as above but added to WBAI's "outstanding balance receivable."
- We have also paid out \$16,000 in back pay in the form of raises that had failed to be paid out going back to 2021.

Programming/Staff Notes:

- We had to rebuild the trust of listeners and producers alike which is why we did not do preemptions, other than for important events like Mayor Adams indictment, Oct. 18's No Kings Day and our national coverage of election night.
- ➤ We helped lead a revival of national programming including No Kings Day Oct. 18 that included six time zones, enlisted dozens of Pacifica reporters and was picked up by dozens of affiliates while also being run here in New York City and over KPFK's air in Los Angeles. We just did a five hour We Decide: 2025 national elections return program working with the Pacifica Affiliates and KPFA's News Department.
- We have produced new programs like Democracy & Destiny, which was underwritten for \$15,000 from the Rockefeller Brothers Fund.
- We now have Labor and Healthcare Confidential with Marianne Pizzitola on Mondays at 5 PM
- > Jesse Lent has been brought on as a part time producer of /We Decide: America at the Crossroads with Jenna Flanagan.
- News Director Rebecca Myles' program Frontline Voices continues to get traction.
- > WBAI now has six union employees, up from four.

- We are finally starting work on building out Studio B which will give us the ability to produce radio outside of the LIVE air broadcast studio which will generate additional revenue, additional editorial product and provide redundancy for Master Control.
- We are also working regularly with the Craig Newmark Graduate School of Journalism at CUNY to produce /Audiofiles/, which provides a LIVE on air showcase for the program.
- In an act of solidarity with the Pacifica Affiliate Program we are working with Ursula Ruedenberg and the folks at WIOF, the Woodstock, NY Pacifica affiliate to upgrade their broadcast capability.

Streaming and Archiving:

We've completed some major structural changes to the way we provide and archive our audio stream:

- Upgraded Barix Encoder to Telos Encoder, for more durability and customization
- Added an additional Telos encoder, to maintain one encoder per internet connection (Verizon and Spectrum). This ensures we have an available backup stream in the event of an outage
- Moved archiving software directly into the studio, on a dedicated server on the studio intranet. This eliminated any disruption in internet service from affecting archive recordings
- Ensured archive redundancy, by retaining an additional recorder in the cloud
- We also plan to implement a new piece of software LiquidSoap. This will have the ability to take both copies of our streams from both internet connections simultaneously, and seamlessly switch between them if any one ISP has a service issue.

- The information on the Pacifica website regarding filling interim positions for GM and PD is conflicting. Some notifications are that positions were filled in May, June, and July. New

- applications for IGM and IPD were closed on Oct 15, 2025. Three stations (WPFW, WBAI, and KPFK) were re-opened to new applications until 12-31-25.
- Pacifica hired a permanent General Manager for KPFT last summer. If a permanent GM was hired for KPFA, that name has not been announced.
- It's difficult to find someone who will do the job well at the salary given in very expensive cities.
- The next meeting will be 11-25-25 at 7 pm in Executive Session.

Dear LSB,

I just wanted to provide this written report to update you on our efforts to revitalize WBAI so that it can help the Pacifica Foundation fulfill its mission which is perhaps more critical for our nation than it has ever been. Since Keziah and I have taken responsibility for the daily operations of the station back in June of 2024 we have consistently made its payroll and health care premium insurance. This was accomplished while at the same time having to replace the existing fundraising model which was heavily reliant on the sort of merchandising that the FCC Consent Decree Pacifica entered into last year by the Foundation expressly prohibited. We also had to overcome major reputational damage from the station's prior failure to send out premiums we had taken money for. (We continue to work to resolve this as these cases arise.)____ At the same time, we had to reset the programming and get back the listener base which had eroded so dramatically it no longer registered on the Nielsen's. NO ONE WAS LISTENING. Producers would be seemingly randomly preempted for these merchandising shows. Key to listener support is maintaining trust between the listener and the station that the programs listeners tune in for will be there on a regular basis. ____ We have made establishing this *continuity of community engagement* our top priority and we have been told by Nielsen we know register a .3 cum which reflects 130,000 listeners. We have done only one conventional pledge drive last winter when we set a goal of \$125,000 and exceeded that by \$17,000 with 604 donations.____ Out of that pledge total was \$56,340 from unions, 108 new donors, 131 returning donors and 73 new WBAI Buddies.____ Thanks to Cerene Roberts, I started to investigate the issue of the subcarrier fees that historically Pacifica collected for the

use of our transmitter. Historically, this service generated hundreds of thousands of dollars across Paciifca's stations that offered it. But over time, the subcarrier market shrunk but there are still two here at WBAI, an Italian and Spanish Radio Maria that on paper generate \$7,500 monthly. The Italian subcarrier is apparently current but that money goes directly to Pacifica national. It continues to be the professional opinion of the management team that the revenue realized from the subcarrier fees should be used to pay down the monthly \$17,000 tower rent that makes the subcarrier service possible. It's not unlike the owner of an apartment complex collecting rent but neglecting the mortgage for the building. After a visit to the Times Square site, I learned from our longtime field engineer Jake Glanz that the subcarriers slightly diminish our signal and that both he and John Ameleh have to sometimes provide technical assistance to the carriers. After several months of research and consultation with John Ameleh, I learned that at least one of the accounts had not been paying and that apparently invoicing had broken down since the pandemic even as WBAI's tower rent of \$17,000 rent went unpaid month after month. I determined who the responsible individual was within Radio Maria that apparently had not been billed by Pacifica. Stephnie Wells gave me permission to negotiate with Radio Maria to get some kind of payment, even though Pacifica had apparently failed to invoice for it since the pandemic started. In September, I notified Radio Maria that we needed to be paid at least going back to January or we would terminate the service on Oct. 15. That week we got a \$25,000 wire transfer in our bank account from Radio Maria with a commitment for another \$10,000 as well as their pledge to sign a contract which is now under legal review. Shortly thereafter, that money was removed from WBAI's bank account by Pacifica National without notice or explanation. After a strong protest from the WBAI local management team, we were told that the foundation would pay one and a half months' tower rent out of that. Yet, we were told that tower "payment being made by the National Office will be added to the outstanding balance receivable that WBAI owes to the National Office, and this information will be shared with the PNB." Over the last 18 months, thanks to two bequests and one individual donor we have paid close to a half-million dollars in back tower rent and are now not a year behind, but three months. We understand that Pacifica intends to continue keeping that practice of harvesting that subcarrier income and not directing it to the tower rent. We will be doing a pledge drive *starting on Dec. 2* through the end of the year. Over the next year, we will hold a one week pledge drive every quarter with the expectation of making at least \$100,000 each time. We had to rebuild the trust of listeners and producers alike which is why we did not do preemptions, other than for important events like Mayor Adams indictment, Oct. 18's No Kings Day and our national coverage of election night. Report from PNB Director-in-exile Alex Steinberg 11.12.2025

• The New Day dominated Pacifica National Board continues to use bullying tactics to intimidate those PNB members who do not agree with them from speaking out.

- In addition to the blatantly illegal suspension of myself and Director Donna Carter from the Pacifica National Board that happened in August and September respectively after two separate kangaroo courts found us "guilty", the Chair of the PNB, Susan Young, now silences and removes anyone from a PNB's meeting's zoom call if she decides that person is being "dilatory", on the basis of nothing more than her claim that the person is being "dilatory". If the Chair of the PNB says so, it has to be true and no appeals are allowed. Therefore, perfectly legitimate motions like making a "point of order" are rejected without any due process and in complete defiance or parliamentary procedure as defined in Robert's Rules of Order. This happened to Director Cerene Roberts at the most recent PNB meeting of November 6.
- That PNB meeting, just like other recent PNB meetings, are full of reports that provide almost no
 information about the state of Pacifica's finances but contain lots of promotional advertising
 about the great job that is being done by Pacifica management with the assistance of the New Day
 PNB. The New Day Directors fall all over themselves congratulating themselves for the great job
 they and Pacifica management has been doing.
- In the meantime, Directors are suffering from what we can describe as information starvation. There has been no Profit and Loss statement from the National Office for months so it is not possible for Directors to make any informed decision about Pacifica's financial problems. We don't know for instance where revenue is coming from at each of our stations and what expenses they are incurring. We don't know if there is a trend upwards or downwards as we are unable to compare the numbers this year from previous years. In terms of revenue, we have no breakdown so we don't know where revenue is coming from whether it is from listener subscribers, major donors, grants, etc. and if such revenue is sustainable or a one time event.
- The New Day Day-aligned PNB Directors see no problem in this lack of information. They apparently are not aware that by acquiescing to management's failure provide financial information they are abandoning their fiduciary responsibilities.
- Finally, every auditor of Pacifica's finances for the past several years has recommended that Pacifica should hire a Controller to provide some independent oversight of finances. Not only do we not have a Controller, we don't even have a CFO. That means there is no oversight at all of Pacifica's finances.
- We also don't have any information about the success or lack of success of our programming. No breakdown is being provided as to the listenership or revenue generated by different programs and what trends these indicate. Are some types of programming being favored over others because of possible donations from supporters of those programs. That would be a blatant violation of FCC guidelines. In the past we had safeguards established to ensure such things wee not happening. What safeguards are there today? Now that evaluation of local programming has been taken away from the LSB, what evaluation is happening?

- In addition Pacifica's non-profit status continues to be at risk. Pacifica continues to be out of compliance with California's rules for Charitable organizations and its status as a non-profit with the right to raise funds has been suspended. Although the California AG's Office is for now allowing Pacifica to continue raising funds despite its suspension, this is obviously a very precarious situation which should not be minimized. At the bottom of the suspension has been the failure of Pacifica to provide any audits for 3 years in a row. Pacifica has not provided an audit since fiscal 2021. It is currently backdated on audits for 2022, 2023, and 2024 and in a few months will be backdated for the 2025 audit. To add to this mess the Audit Firm that has been doing Pacifica's audits and which were expected to do the audits for fiscal 2022 and 2023 has withdrawn. No satisfactory explanation has been provided as to why the audit firm withdrew.
- As of this writing the lack of financial information did not prevent the National Finance Committee of the Pacifica National Board from approving the budgets of several of Pacifica's business units without a dissenting vote. On what basis these budgets were approved is a good question. In years past the NFC routinely sent back budgets to the Local Stations Boards when it determined that the estimates for revenue and expenses in the proposed budget were not based on realistic figures that were in line with previous years. Since LSB's have been iced out of reviewing finances this feedback mechanism between local and national finances is gone. And there is nothing to replace it with either. We can only wonder if these budgets were approved by the Oracle of Delphi.
- Another recent action of the PNB has been the creation of a Personnel Committee whose
 mandate is the evaluation of Pacifica's Executive Director. There is a deadline that has been set of
 completing an evaluation before the end of the year. It is not clear why this rush when the ED's
 contract is almost a year away from expiring.
- We are also seeing how the PNB and the Pacifica management is proceeding as if the LSB's do not exist. This is evident in the current hiring process for General Mangers of each of the Stations, which does not include any input from the LSB's. In still another anti-democratic action, the PNB majority is insisting that any proposals for bylaws amendments must go through the Governance Committee. Keep in mind that the Governance Committee, like the Finance Committee, has stripped away all input from LSB members who are not Directors.
- Finally I can report that the legal challenge to the New Day takeover of Pacifica is proceeding. We filed a notice with the California Court of Appeals. We plan to show that the so called settlement agreement was based on collusive conduct between Pacifica's new attorney, (who was hired after Pacifica's long time attorney Arthur Schwartz was fired because he opposed the fraudulent settlement agreement) and the New Day attorney. We will also show that the agreement that was reached violates the Pacifica bylaws and an earlier court ruling on the status of the 2021 Referendum. We are determined to return Pacifica to its members and hold accountable those Directors who facilitated the collusive takeover of Pacifica by New Day.
